Re: Presentation on Request for Water Services

#### Background:

Based on a growing demand for accessible, potable water in the STWA water system there has been an increase in contacts from large volume, industrial users. Recently, Tex-Isle, Inc reached out to the STWA learn about water options for their facility on CR 30/I-69 South in Nueces County.

Tex-Isle's Robstown Facility is a manufacturing facility for pipe mill, heat treatment, inspection, and threading operation. Tex-Isle has its entire operation and steel supply located within a 60-mile radius in South Texas. Tex-Isle Robstown currently has 115 hourly employees with plans to expand their facility. Tex-Isle currently receives water hauling services to help supplement their current well water supply.

#### Analysis:

The Tex-Isle presentation will provide a general overview of the work they perform and the demand they have for STWA water near or along the 42" Transmission Line.

#### **Staff Recommendation:**

Receive presentation and provide feedback to clarify any concerns.

#### **Board Action:**

No action is needed and is for informational purposes only.

#### Summary:

Tex-Isle along with other industry are seeking out reliable water supplies to support possible growth or development within our service area. The attachment will provide some general concepts about the company and representatives will be on hand to answer the board's questions.




Tex-Isle has the full line of processing and valueadded capabilities in line with the largest most sophisticated steel pipe mills in the world. Our entire operation and steel supply is located within a 60-mile radius in South Texas. Our goal is to provide American Steel and American jobs.

Tex-Isle Robstown currently has 115 hourly employees. Hourly wage rates are an average hourly pay of \$25.00 per hour.

## **ERW Mill Specifics**

- Tex-Isle opened our first ERW pipe mill in 2021. It is co-located with our API 5C5 Processing facility in Robstown, Texas.
- Total production capacity is up to 350,000 tons annually, with 125,000 tons per year slated for API 5CT material.
- The mill can produce steel tubes ranging from 2.375" 8.625"OD with wall thicknesses between 0.118" 0.500".
- Equipment for the mill is supplied by the industry's leading manufactures such as Fives Oto, Thermatool, and Linsinger.
- Mill can produce specialty grades and specifications including restricted and enhanced yields.



## Environmental Stewardship

Greater focus is being given on environmental responsibility. The Mill Expansion project was another step for Tex-Isle in an ongoing effort to be a partner to industry and the environment.

Tex-Isle's President Chris Kayem has described Tex-Isle's focus on the mill as "making a green, environmentally conscious product in a traditionally carbon intensive manufacturing process. This facility represents our ongoing commitment to expanding our manufacturing capabilities, while also lowering our carbon footprint. We are constantly evaluating further opportunities to achieve both of these goals."

Ways Tex-Isle's mill focuses on ESG stewardship include:

The facility is designed to run on 100% electric technology.

Hot Rolled-Coil will be supplied by manufacturers utilizing Electric Arc Furnace (EAF) Technology – 85%

recycled steel.

Concentrated supply chain removes the need for extra and/or extended transport of material over the road, rail, or oceangoing.

These factors place Tex-Isle's GHG life cycle emissions in the top 20% of global tubular producers<sup>(1)</sup>.



#### Background:

On the February 24, 2023 board meeting the Directors approved entering into agreements with the Water Finance Exchange and International Consulting Engineers to identify key areas throughout the STWA system. This long-term visioning includes listing all essential facilities, infrastructure, and financial needs to address needs that have been years or in some cases decades in the making to improve. Our management staff have been in on-going talks with the WFX and in particular ICE to establish our short and long-term needs to ensure we have a safe, reliable drinking water system.

#### Analysis:

This Master Plan is currently considered only 30% complete. With the boards and staff's input the plan can ultimately reach 90% by the next board meeting. Finally, being 100% complete once the board approves the final plan, which is estimated to take place within the next two board meetings.

#### **Staff Recommendation:**

Review ICE's Master Plan draft and provide input into areas of the system that may not be included with this visioning.

#### **Board Action:**

Provide input. No formal action is required until the final plan is ready for adoption.

#### **Summary:**

The list of projects is based by each systems needs. Both Water Supply Corporations have been included in the master planning and will have their individual list of projects presented at their next corporation meetings. Seek out projects that benefit parts of the entire wholesale system benefits not only the Corporations and member communities but also the STWA as a whole.

Your input will be considered for our future planning and growth.

For the month of April 2023, due to the rain we have not been able to go back north of CR 30 at US Ecology due to bad bond between STA #852+90 to STA#877+02 once completed and fixed we will continue north of FM 2826. Martin Marietta, has still been cleaning up our easement so that we have access to install anodes but not completed. CP crew has installed 576 anodes on 397 joints on Contract 2 of the 42" water line. We have replaced 46 old test stations since the beginning of the project. We have completed 45,259 feet out of 51,511 feet in Contract 2. Once all Contracts are complete, we can contact to submit quotes for a survey to determine continuity throughout the 42" water main, but the crew has remained busy with other CP related tasks and assisting with other field work for all three entities.

#### We continue to work on CP related work and helping with other field personnel as follows:

- Perform maintenance and test rectifiers/test stations.
- Maintain grass with herbicide around vaults, manholes, test stations and rectifiers along 42" line.
- Perform locates for 42" water main.
- Assist O&M with ongoing operations.
- Worked on getting quotes for a new rectifier on CR 28 & Highway 77 to provide better Cathodic Protection for Contract 2.
- Worked on locating value north of FM 1118 and reinstalling value box and cement cover due to TEX DOT project on Hwy 77 that got covered up and ripped out for RWSC.
- Worked on barricades for flush values and setting them south of FM 2826/Hwy 77 and west on CR 12/Hwy 77 for NWSC.
- We have been coordinating and working together with contractors with project for Tesla locate the 42" water main.
- Exercise values on 42" water main @ FM 2826, Driscoll, Bishop, CR 36, Stevens Plant & Kingsville Valve.

- 1. Individuals are entitled to an exemption from taxation by the Authority of 1% of the appraised value of their residence homesteads, or \$5,000 of the appraised value of their residence homesteads, whichever is greater.
- 2. Individuals who are disabled or who are 65 years of age or older are entitled to an exemption from taxation by the Authority of \$12,000 of the appraised value of their residence homesteads.
- 3. Disabled veterans are entitled to the exemptions from taxation allowed by Section 11.22, Property Code.

In accordance with Section 26.01(e) of the Texas Property Tax Code, I am enclosing the 2023 Certified Estimate of Values for your taxing entity. The 81st Texas Legislature changed the deadline for the Chief Appraiser to prepare and certify estimates of taxable value to the assessor for each taxing unit by April 30th of each year or the next business day if the 30th falls on a weekend (Section 1.06 of the Texas Property Tax Code). This makes a significant difference in the benefit that these values present to you at this point in time for the purpose that you are intending to use them for. Please remember the majority of the exemption application deadlines are April 30, 2023, the majority of special appraisal applications deadlines are April 30, 2023, rendition extensions are through May 15, 2023, and some may be through June 1, 2023. All these issues play a part in a less accurate estimate of value. Other potential loss may occur due to allowable late filing of exemptions and due to additional information provided to the appraisal district by the taxpayer addressing specific issues with their property before the final roll is approved. I will be providing you with another set of estimated values no later than June 30, 2023, so that you will be given the ability to work with some updated information.
