1. Call to Order.

Mr. Jose Graveley, Board President, called the Regular Meeting of the STWA Board of Directors to order at 5:30 p.m. at the Courthouse Annex Law Enforcement Center, 1500 E. King, Kingsville, Texas. A quorum was present.

2. Citizen Comments.

Mr. Graveley opened the floor to citizen's comments. No comments were made.

3. Approval of Minutes.

Ms. Lowman made a motion to approve the minutes of the February 18, 2025 Public Hearing and Regular Meeting as presented. Ms. Rodgers seconded. The motion passed by unanimous vote.

Mr. Rodriguez made a motion to approve Payment of Bills as presented. Ms. Rodgers seconded. The motion passed unanimously. Ms. Lowman made a motion to approve the Quarterly Report and Treasurer's Reports as presented. Mr. Rodriguez seconded. All voted in favor.

- 5. Operation and Maintenance Reports.
 - O&M Technical Report
 - Cathodic Protection Report

Mr. Sendejo presented the O&M Technical Report for the weeks of February 17 through March 17, 2025. He asked for direction from the Board on anything additional to be included on future reports but there were no requests made by the Board. Mr. Marez reported on the Cathodic Protection Presentation by Mr. Hector Barbosa at TAMUK and said that he would forward the link to the recording of the presentation to the Board.

6. Updated STWA Water Conservation and Drought Contingency Plan.

Mr. Marez presented an updated Water Conservation and Drought Contingency Plan for the Board's consideration. He explained that the City of Corpus Christi made changes to their plan therefore STWA's plan was modified to reflect the same changes. The Plan now includes six stages. Attorney Charles Zahn explained that as a Corpus Christi wholesale customer, STWA is required to adhere to the City's changes. The city provides percentage allotments and violators will be imposed a surcharge of two times the cost of the water. Additionally, decisions on the plan are now the responsibility of the city council instead of the city manager.

7. Resolution 25-07. Resolution adopting an updated Water Conservation and Drought Contingency Plan for the South Texas Water Authority.

Ms. Lowman made a motion to adopt Resolution 25-07 adopting the updated STWA Water Conservation and Drought Contingency Plan. The motion was seconded by Mr. Rodriguez and passed by unanimous vote.

8. <u>Declaration of surplus property.</u>

Mr. Marez presented a list of items no longer in use and ready to be declared surplus. The items are a 2018 Ford pickup, one 2020 Ram pickup, one HP Color LaserJet Pro M255dw Printer and six Dell desktop computers. Mr. Graveley stated that he prefers for the computers to be donated to a non-profit organization, if possible, instead of destroying and disposing of them.

9. Resolution 25-08. Resolution authorizing the sale of surplus property of the South Texas Water Authority.

Mr. Rodriguez made a motion to adopt Resolution 25-08 declaring the items as surplus and authorizing sale. Ms. Pena seconded and all voted in favor.

10. Amendment of South Texas Water Authority Personnel Policies - Holidays.

Mr. Marez requested that the Board consider adding Easter Monday to STWA's list of holidays. He explained that STWA currently observes Federal Government holidays and attempts to follow the same holidays as Kleberg County. Easter Monday has been added to Kleberg County's holidays and he asked that the Board amend STWA's Personnel Policies to include Easter Monday in the list of observed holidays.

11. Resolution 25-09. Resolution adopting revised South Texas Water Authority Personnel Policies – Holidays.

Mr. Rodriguez made a motion to adopt Resolution 25-09 adopting the revised South Texas Water Authority Policies – Holidays. Ms. Rodgers seconded the motion. All voted in favor.

- 12. STWA Master Plan I.C.E.
 - Presentation I.C.E.
 - Bidding process for pump station improvements

Mr. Ivan Luna of I.C.E. and Rogelio Rodriguez of Water Finance Exchange provided a brief presentation on STWA's Master Plan. Mr. Luna stated that a draft of the updated Master Plan should be available next week. The updates include estimates for short-term and long-term needs resulting from projected population growth and water demand projections, integration of the brackish desalination project and Ricardo well project, the Seven Seas Brackish Water project, the groundwater feasibility study, a cathodic protection study, asset management strategies and engineering recommendations. Mr. Rodriguez added that an application has been submitted for funds to address water loss but if STWA is not invited for funding, other options are available.

13. Seven Seas Project.

Mr. Kasy Stinson of Seven Seas reported that attorneys will be meeting regarding the lease for property and he expects the lease to be signed by the end of the week. Well drillers are finishing up a nearby project and will then take one to two weeks to identify a location for a well, followed by construction of a monitoring well. Finally, he reported that Phase One of the Environmental Site Assessment of the permitting process will begin March 26th. No Board action was taken.

14. Water Supply Contract with the City of Corpus Christi.

No update was presented on the Water Supply Contract with the City of Corpus Christi. No action was taken by the Board.

15. **Resolution 25-10.** Resolution of Commitment to the Coastal Bend Water Alliance.

Mr. Marez explained that in response to the urgent need for coordinated action, regional leaders have proposed the formation of the Coastal Bend Water Alliance, a unified coalition of cities, counties, industries and economic stakeholders dedicated to securing reliable and resilient water supplies for the region. He asked that the Board consider adoption of Resolution 25-10 to formally join the Coastal Bend Water Alliance and endorse a unified regional approach to water supply development. Mr. Graveley made a motion to adopt Resolution 25-10, Mr. Rodriguez seconded and all voted in favor.

16. Nomination of candidate for the Kleberg County Appraisal District Board of Directors.

Mr. Marez explained that due to the recent passing of a Kleberg County Appraisal District Board member, a vacancy is open on the KCAD board. He asked that the Board consider naming a nominee. Mr. Gravely said he had been approached by Bill Colston, Jr. requesting support for the position. No other nominees were named.

17. Resolution 25-11. Resolution submitting nomination for candidate for position on the Board of Directors of the Kleberg County Appraisal District

Mr. Graveley made a motion to nominate Bill Colston, Jr. to the Kleberg County Appraisal District Board of Directors. Mr. Rodriguez seconded. The motion passed by unanimous vote.

Mr. Marez reported that a meeting will be needed with Raftelis in order to continue water supply contract negotiations with the City of Corpus Christi. He also reported that review of the first round of applicants for the Finance Manager position has begun and they are being screened for minimum qualifications. He hopes to present qualified applications at the next meeting.

19. Adjournment.

With no further business to discuss, Ms. Lowman moved to adjourn the meeting at 6:52 p.m. Mr. Graveley seconded. The motion carried.

Background:

As part of the Authority's ongoing efforts to remove outdated supplies staff is presenting a request to declare several items for scrap, resale, or disposal. The items identified are no longer in service and are no longer suitable for use in Authority operations. To comply with asset management and disposal procedures, these items must be formally declared as surplus before they can be sold or otherwise disposed.

Analysis:

The following items have been evaluated and determined to be surplus:

- One Dump trailer 12' x 6.5' (total gross carrying weight 77,000 lbs.
- Rolling Map Carts
- Computer Printers

These assets are no longer needed for daily operations. The trailer has exceeded its useful life for the Authority's needs, and the office equipment has been replaced with updated technology. Disposal through sale is consistent with past practice and provides an opportunity to recover some residual value.

Staff Recommendation:

Re: Amendment of STWA Personnel Policies - Leave

Background:

The South Texas Water Authority (STWA) currently permits newly hired employees to access and use their accrued medical and personal leave beginning on their first day of employment. While this practice has been consistently applied in both current and past operations, it differs from standard personnel policies commonly used by other public agencies and private sector employers.

In most HR practices, new employees are subject to a probationary period—typically ranging from three to six months—before being eligible to utilize accrued leave. This approach ensures adequate time for evaluating job performance and cultural fit while encouraging attendance and dependability during the initial stages of employment.

Analysis:

The current STWA practice allowing immediate leave usage presents the following concerns:

Accountability & Retention: Allowing leave use from day one can reduce employee accountability and does not align with best practices for probationary evaluations.

Operational Disruptions: Unscheduled or excessive absences early in employment may disrupt department workflows, especially for critical operations.

Industry Benchmarking: According to the Society for Human Resource Management (SHRM) and multiple public sector personnel manuals, most employers require a waiting period before leave can be used. Common examples include: State of Texas: Many state agencies impose a six-month wait before use of sick or personal leave. TRWA & TCEQ Guidelines: Recommend probationary evaluation before benefits and leave are fully accessible.

STWA already employs a six-month probationary period for new employees. It would be consistent and reasonable to align the leave usage policy with this existing benchmark.

Staff Recommendation:

Staff recommends the Board amend STWA's personnel policy to establish a six-month waiting period before new or rehired employees may begin utilizing any accrued medical or personal leave. Employees would continue to accrue leave during this time but could not use it until successfully completing their probation.

Board Action:

Approves a revision to STWA's personnel policy to establish a six-month waiting period from the date of hire before newly hired employees may utilize accrued medical or personal leave. This policy shall take effect immediately upon Board approval.

Summary:

Aligning leave usage with the established six-month probationary period will bring STWA policy in line with common HR practices, support workforce consistency, and help ensure operational reliability during the critical early period of employment. Staff believes this change will promote a culture of responsibility while maintaining fairness in leave accrual and usage.

Re: STWA Water Master Plan - 2025 Update

Background:

The South Texas Water Authority (STWA) continues to plan for the long-term sustainability and reliability of its water system. As part of this effort, the Water Master Plan is updated periodically to assess current system conditions, anticipate future demands, and guide infrastructure and operational improvements. The last completed version of this plan was the STWA Water Master Plan—2023, which has now been finalized, signed, and sealed. The previous Master Plan and this current plan are the first formal attempts by the STWA to gather and track all improvements needed for the entire water system. The creation and use of our Master Plan was instrumental in being selected by the Texas Water Development Board (TWDB) to receive state funding for water improvements for our infrastructure so the continued support and review is essential.

Analysis:

To assist the Board with ongoing and upcoming planning efforts, the 2025 Water Master Plan (95% DRAFT) is being provided for your records and reference. International Consulting Engineers staff is currently waiting for approval by the Texas Water Development Board for the updated plan. This updated version will address STWA's future system needs with a forward-looking scope and comprehensive analysis.

The 2025 Water Master Plan will include the following major updates and new information:

- 1. Population Growth & Water Demand Projections: Updated estimates for short-term (5 years) and long-term (50 years) needs.
- 2. State Water Plan Projects: Integration of the Brackish Desalination Project (Nueces County) and the Ricardo Well Project (Kleberg County).
- **3.** External Water Management Strategy Projects: Notably, the Seven Seas Brackish Water Treatment Project.
- 4. Groundwater Feasibility: Updates based on findings from the AGS study.
- **5.** Cathodic Protection Study: Evaluation of corrosion control strategies to ensure safe and sustained operations.
- **6.** Asset Management Strategies: Focused on guiding STWA's infrastructure development and lifecycle planning.
- **7.** Engineering Recommendations: Suggestions for additional study and improvements to ensure safe and efficient water distribution.

Additionally, the report includes updated Capital Improvement Plan (CIP) estimates to support future funding applications and planning.

Staff Recommendation:

Staff recommends that Board members review the 2025 Master Plan (95% DRAFT) and the major updates. This will ensure a seamless transition into planning and prioritizing future capital investments and projects.

Board Action:

Adopt plan as presented.

Summary:

The STWA Water Master Plan 2025 (95% DRAFT) is available for your reference. This update will be discussed in its entirety during the April 22, 2025 board meeting. All key updates provided in the Analysis section is for your review related to water demand, future projects, groundwater feasibility, system protection, asset management, and CIP revisions.

These efforts are critical to STWA's commitment to delivering safe, sustainable water services to the communities we serve.

It is one of twenty-four COGs in Texas, all legally defined as political subdivisions of the state. They are governmental agencies with legal responsibility for multi-jurisdictional planning in program areas such as emergency communication systems, criminal justice, solid waste management, environmental protection, and homeland security planning. The COG meets 11 times each year to guide decisions on grant funding opportunities and partnerships throughout the coastal bend.

Analysis:

The STWA has been without a designated voting member or alternate member participating in recent COG meetings. This position is available for the STWA Board of Directors or staff to fill either role. Since the STWA has new Directors joining their Board the time to designate is ideal.

Staff Recommendation:

Selecting members to participate in the COG allows the STWA to vote on all policy and financial issues facing governmental entities for 11 coastal bend counties.

Board Action:

Staff recommends the board select a primary and alternate member of the COG.

Summary:

The STWA has a position available to serve as a member of the Coastal Bend Council of Government. There are two slots on the COG for STWA members with the first serving as the Primary voting member and a second as an alternate position should the primary member not attend or be unable to cast a vote on any items before the COG board.
